In pursuance of the letter of Ministry of AYUSH, Govt. of India vide no. L-11011/2/2020-(EP-1) Part-2 dated 30/03/2021, it is for general information that 4th counseling will be held on **31/03/2021** at **2.00 PM** in **Govt. Ayurvedic College, Guwahati** for selection of the candidates from State Quota for admission into MD/MS (Ayu) course against the following vacant seats under All India Quota at Govt. Ayurvedic College, Guwahati for the session 2020-21 (**which are lying vacant after the 3rd/Mop-Up round of AACCC PG counseling 2020-21**).

Hence, application are invited from the eligible candidates under State Quota as per the above said letter of the Ministry of AYUSH, Govt. of India vide no. L-11011/2/2020-(EP-1) Part-2 dated 30/03/2021, for admission into MD/MS (Ayu) course in Govt. Ayurvedic College, Guwahati for the session 2020-21, against the vacant seats as mentioned above.

The Application Form is available in the website of the Directorate of AYUSH, Assam, i.e. <https://ayush.assam.gov.in> and website of the Govt. Ayurvedic College, Guwahati, i.e. gacassam.webs.com

The duly filled up Application Form along with its enclosures must be submitted at the time of counseling in case the candidates who have not applied/ admitted as per the earlier Educational Notices for counseling for admission into MD/MS (Ayu) course in Govt. Ayurvedic College, Guwahati for the session 2020-21.

The candidates who have been selected/admitted or who have applied as per the earlier Educational Notices for counseling for admission into MD/MS (Ayu) course in Govt. Ayurvedic College, Guwahati for the session 2020-21, may also appear the 4th counseling for changing their subject against the vacant seat if desire or for selection for admission respectively.

Candidates are requested to appear personally before the Selection Board along with all relevant documents, testimonials etc. in original on the scheduled date and time as mentioned above, failing which he/she will forfeit the merit position and no claim shall be considered later on.

The candidates possessing the degree of Ayurvedacharya (Bachelor of Ayurvedic Medicine and Surgery) from a recognised University or Board or medical institution specified in the Second Schedule to the CCIM Act and enrolled in Central register or Assam State Council of Indian System shall be eligible for admission in the post-graduate course.

To be eligible for state quota seats, the candidate must be a citizen of India and his/her parent must be permanent resident of Assam.


Due to prevailing COVID-19 pandemic, the Ministry of AYUSH, Govt. of India, vide letter no. L-14011/18/2019-EP-1 dated 08/12/2020, decided to extend the last date/cut-off date for completion of internship up to 31st December, 2020 to be eligible for admission into ASU & H PG courses for the academic session 2020-21. However, the candidates must have been started their one year rotatory internship on or before 1st November, 2019.

The subsequent vacant seat/seats (after changing the subject) will also be filled up by the eligible candidate under respective category of candidates.

The Selection will be made in accordance with the merit of the All India AYUSH Post Graduate Entrance Test (AIAPGET)-2020. The eligibility criteria in case percentile of marks in AIPGET-2020 for admission into MD/MS (Ayu) course in Govt. Ayurvedic College, Guwahati for the session 2020-21, will be considered as per the letter of Ministry of AYUSH, Govt. of India vide no. L. 11011/1/2020-EP-1 (Part-1) dated 19/03/2021.

In absence of the respective reserved category candidate, the vacant seat will be filled up by the open category candidate applied under state quota seats on basis of the merit position of AIAPGET-2020, subject to fulfillment of the eligibility criteria.

In case of any matter of controversy, the decision of the **Selection Board** shall be final and binding.




