Date : 28th October, 2018.**EDUCATIONAL NOTICE****2nd Counselling for selection of the candidates for admission into MD/MS (Ayu) course in Govt. Ayurvedic College, Guwahati, for the session 2018-19.**

This is for general information that the eligibility criteria for admission into MD/MS (Ayu) course in Ayurvedic Colleges for the session 2018-19, has been further clarified by Ministry of AYUSH, Govt. of India vide no. R-11011/02/2018-EP (IM) Part-1, dated 26-10-2018. As such, the eligibility marks of the entrance test for admission in case of general candidates shall be Fiftieth (50th) percentile, in case of candidates belonging to the Schedule Caste, the Scheduled Tribes and regular central or state Government service candidates shall be Fortieth (40th) percentile and in case of candidates belonging to the Other Backward classes shall be Forty fifth (45th) percentile in the AIAPGET-2018.

So, in puesday to the letter of Ministry of AYUSH, Govt. of India vide no. R-11011/02/2018-EP (IM) Part-1, dated 26-10-2018, application are invited from the eligible candidates who have appeared in the All India AYUSH Post Graduate Entrance Test (AIAPGET) -2018 and completed their internship on or before 31st October, 2018; for counseling for admission into MD/MS (Ayu) course in Govt. Ayurvedic College, Guwahati for the session 2018-19, against the vacant seats under state and NEC quota.

The vacancy positions of the PG seats in different departments under state and NEC quota are as below-

To be eligible for state quota seats, the candidate must be a citizen of India and his/her parent must be permanent resident of Assam.

For NEC quota, the candidate must submit the duly filled up “Application Form” along with the certificate in Annexure-I, with necessary signature as noted thereon.

The Application Forms are obtainable from the **Office the Directorate of AYUSH, Assam, House No.1, Banphool Nagar Path (Near Housefed), Dispur, Guwahati-6 or Principal, Govt. Ayurvedic College, Jalukbari, Guwahati-14 during office hour.** The Application Forms may also be downloaded from the website of Govt. Ayurvedic College,

Guwahati, i.e. gacassam.webs.com or website of Directorate of AYUSH, Assam i.e. ayush.assam.gov.in

The duly filled up Application Form along with its enclosures must be submitted/reached to **Office the Principal, Govt. Ayurvedic College, Jalukbari, Guwahati-14 on or before 05-11-2018**. The incomplete Application Form shall be summarily rejected.

The counseling for selection of the Candidates for admission into MD/MS (Ayu) courses in the said subjects will be held **on 09-11-2018 at 11.00 AM** in **Govt. Ayurvedic College, Jalukbari, Guwahati-14**. Candidates are requested to appear personally before the Selection Board along with all relevant documents, testimonials etc. in original on the scheduled date and time as mentioned above, failing which he/she will forfeit the merit position and no claim shall be considered later on. The candidates who have been selected/admitted as per the earlier counselling for admission into MD/MS (Ayu) course in Govt. Ayurvedic College, Guwahati for the session 2018-19 held on 09.10.2018, may also appear the 2nd counseling for changing of subject against the vacant seats as per merit position.

The Selection will be made in accordance with the merit of the All India AYUSH Post Graduate Entrance Test (AIAPGET-2018) and the marks obtained in under-graduate course (BAMS) as per the PG regulation of CCIM vide Notification No. 4-90/2016-P.G. Regulation dated 7th Nov, 2016. In case of any matter of controversy, the decision of the **Selection Board** shall be final and binding.
